MESSAGE FROM THE BOARD

STEVE STATZ - VICE PRESIDENT

Transition Update

The contract for the engineer has been signed, and the work started in earnest. The exterior of the Clubhouse including siding, stone work, roof, leaders, gutters, and underground drain systems have been inspected. The list generated by our residents regarding common property issues has been consolidated with the Builder/Liaison Committee and transmitted to the engineer. There are 88 residences with common property or drainage issues. The whole community has been examined in the broad overview towards determining the cause of the drainage issues we face. The surrounding properties and township storm drain system are being investigated to help determine how best to remediate the problems identified.

During the month of October, the engineer will conduct a detailed inspection of the Clubhouse interior, and the outdoor recreation facilities. Where required, the engineer will have appropriate consultants review the installation of the facilities such as the bocci courts, pool, and tennis courts. The engineer will inspect the pumping station in coordination with the contractor awarded the maintenance contract.

Towards the end of the month, the engineer will meet with our Transition attorney to determine the final report format that is required. It is expected that a draft of the final report will be ready for comment by the attorney in November.

COMMITTEE REPORTS

Finance Committee

Allen Goldstein - Chairperson

The Finance Committee submitted to the Board a 2009 Budget Proposal on September 13, 2008. We received input from most, if not all, of the HOA's committees and we believe that this 2009 budget proposal submission to the Board is a team effort.

Thanks to all.

The proposal reflects the best information available from the committees, the management company, IMPAC, and from the Board's President and Treasurer. In addition, we received input from the Vice President of the Board related to transition matters. This information was made available to the Finance Committee during the period August 1 to September 3, 2008, when we finalized our proposal to the Board.

2009 Budget Proposal Summary:

This proposal is an increase of approximately \$21,000 over the 2008 budget representing a 4.4% increase in expenses compared to the 2008 budget. This increase is primarily the result of increased maintenance expenses previously borne by the Robertson Douglas Group or not performed such as for the pumping station and exercise equipment in the gym, a 5% increase in our IMPAC management fees due under the contract, the need to mulch the common areas in 2009 and other plantings in our community including all of the circles in the various cul de sacs which have not already been planted. These additional expenses are offset in part

by reductions in insurance premiums, office supplies, and expected transition costs.

Matters of Interest:

During the Committee's deliberations, we discussed a number of matters that we shared with the Board. These matters included the following:

- An Engineer's Report is expected to be received before 2009 begins. This new report is expected to update the cost estimates to replace our infrastructure that was included in our community's offering document and is the basis for the annual provision to the replacement reserve in the budget. This report is expected to suggest a need to significantly increase the amount provided annually to the replacement reserve. Once this information is available, the Board will need to consider how to address these estimates of our long-term financial needs. The Finance Committee is prepared to assist in this determination and there may be other committees or experts within the community that the Board may choose to call upon for assistance with this matter.
- On certain common property, there are apparently irrigation issues and dead trees which may require longer term and potentially costly solutions. These were not matters to be addressed in the annual budget process. The Board may want to consider these items of an extraordinary nature and seek the assistance of experts to determine what the appropriate solutions may be and related costs are, then share the findings with our community so that a consensus can be built as to how best to address these questions. The budget proposal does not provide for pursuing this matter or retaining experts.
- The snow removal budget is proposed with the understanding that we cannot predict the frequency and intensity of snow storms. We recommend to the Board that whatever amount is included for snow removal in the budget that the Board approves, that homeowners are advised that there may need to be a separate special snow removal assessment, should the amounts expended for snow removal exceed the budgeted amount.
- The Committee discussed the possibility that 2008 might produce revenues in excess of expenses; this might happen because of lower than budgeted Clubhouse, insurance, transition, and snow removal expenses. We factored this information into the development of the 2009 Budget Proposal that we submitted to the Board; because this

possibility exists, we encourage the Board to move forward to approve a 2009 Budget and defer as long as possible the establishment of the 2009 monthly maintenance fee amount until it can be determined with a high degree of certainty whether the 2008 revenues will exceed expenses and could be used to offset part of the 2009 Budget. For every \$2,784 of 2008 excess revenues over expenses, the 2009 monthly maintenance fee can be reduced by \$1 provided that in the Board's judgment there is no other community use for any possible excess revenue.

All of the Finance Committee members acted diligently in this process and we know that our community appreciates the effort. The Board may have had additional information, other criteria and priorities to be considered when it finalized the 2009 Budget at its meeting on September 25.

Any budget process is imperfect. However, our process continued to improve in 2008 and we expect that it will continue to improve in the future as long as there is significant continuity on the Finance Committee from year to year.

This 2008 Finance Committee works well together. Although we are a large Committee, we encourage the 2009 Board to reappoint all members of the Committee who wish to continue. We encourage others to join the Committee so that the Committee receives the benefit of hearing different perspectives on the financial matters that affect our community.

In support of the 2009 budget, the Board has voted a \$5.00 increase in the monthly maintenance fee to take effect January 1, 2009.

Hospitality Committee

The Hospitality Committee continues to serve the community in many ways. The Clubhouse library thrives due to the extraordinary care given by Mary Ann Walters. The Sunshine Committee, chaired by Ellie Friedberg, continues its very valuable work for our homeowners. We continue to support the Social Committee, Recreation Committee, Clubhouse Committee and, of course, the Texas Hold-Em and PPP groups.

The Hospitality Desk, located at the Clubhouse, is open on Tuesdays from 11 AM until 12 noon and Thursday evenings from 7 PM to 8 PM. On the evenings of the monthly HOA meeting, the hospitality desk will be open only from 7 PM to 7:30PM to allow our members to attend the meeting. Our members are there to answer homeowners' questions, take orders for key fobs, and support committees in the collection of funds for events.

We have also been requested to help with the upcoming flu and pneumonia immunizations to be distributed at the Clubhouse by the Hamilton Township Health Department on November 17th from 2-4 PM. Several members volunteered to be present to help homeowners complete forms before being immunized.

The Hospitality Committee is going to have a pie sale in November with the proceeds going to support the library. Save your baking time and order a pie for either your dinner table or to take as a gift to your host/hostess. Included in this edition of The Chant is a sign-up sheet for your use. Landscaping /Snow Removal Committee

In mid-August, the Landscape Committee made an inspection of common grounds and related areas in the Enchantment Community. We identified 18 areas that require attention. A detailed report was provided to your Board of Directors.

Specific actions should include, but not be limited to, seeding and fertilization, treatment of hard pan (soil stimulation), along with the installation of in-ground sprinkler systems, where there are none.

Additional actions are to include new plantings and the replacement of distressed shrubs and trees.

Several locations in the community exhibit problems with casual or standing water. This, too, will require some attention.

With the advent of transition from Robertson Douglas, along with the installation of Enchantment's new Board of Directors, we cannot, at this time, provide a timetable for corrective action.

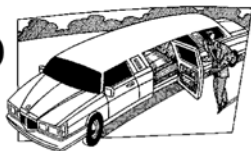
