## KATHY'S KORNER KATHY PLATT

Hi all, time again for your monthly update from the Board. Leaves are falling and the cold air is setting in but your Board is still working hard to keep our community the best in Mercer County. The following are items we are working on:

- 1. The Board and a representative of Robertson Douglas will be meeting in mid-November with two members of the Township to discuss and negotiate the final phase of transition. We are hoping for an amicable conclusion so that transition can be completed.
- 2. Coast is scheduled to do some tree replacement in early November.
- 3. We have requested LMS to remove the trees in the front of the Clubhouse that have either died or are in very poor shape. At this time they will be removed and grass put in its place. If we find at a later date that trees should be replaced, we will do so in the spring.
- 4. The budget was ratified for 2015 and the monthly dues have been increased to \$210 per month starting in January. You will be receiving your new payment books soon. This is the first increase in three years

and is necessary to keep our reserves fully funded and the community kept in pristine condition.

- 5. The budget is posted on our web site for those interested in reading it.
- 6. Gates are finally repaired and working. A new Stop sign was installed on the corner of Sedona and Monte Carlo in an attempt to slow people down and prevent a potential accident from occurring. Please STOP at the sign and proceed at a safe speed.
- 7. The fine resolution will be ratified at the December 11th General Meeting. After it is ratified we will start to initiate fines to those who choose not to obey the rules of the community. You will be notified of what they will be prior to them going into effect.
- 8. The walkway around our pond will be repaired this week and crack filling in the development will also be done in November.
- 9. If you have not completed your census form please do so and return to First Service as soon as possible. We have had a terrific response to this and would like to get the last stragglers in also.

## **BOARD PRESIDENT - STEVE STATZ**

I want to thank all of the volunteers in our various committees and clubs that help all of us to continue "Living the Dream". Volunteers are essential to our community to keep it running smoothly, and to lower our operating expenses. Being a member of a committee also helps form new friendships with our neighbors, and rewards you in unexpected ways. Please consider joining.

The business of the HOA continues to be routine. Our Annual Meeting included election of Jeff



Schenker and Stephen Statz (me) for threeyear terms. Your association officers remain the same: Steve Statz President, Tony Gambino Vice President, Kathleen Platt Secretary, Jeff Schenker Treasurer and Steve Fischberg Trustee. During the meeting, the budget for next year was approved by the Board and resulted in an increase in the Maintenance fee of five dollars per month.

I reported in the November Chant last year (and the year before) that we met with Robertson Douglas and reported that we would start work on replacing portions of our sidewalks and aprons. At the end of the summer, we replaced additional sidewalks that had been raised by tree roots and had become a tripping hazard. This cost was covered by our replacement reserves and will be a continuing expense. We also contracted for a paving company to fix our walking paths and repair part of the parking lot. It is now too late to place more concrete, since concrete work should not be done in freezing weather, or when salt

might be used. The work will be postponed until warm weather returns.

Tree removal and planting will be done this fall and continue in the spring.

Transition is moving at a snail's pace in accordance with the developer's available finances. Our Vice President, Treasurer and I have met with the Township to solicit their advice as to what our options might be. They have assured us that they will hold the builder to his bonded commitments.

It has become our custom to cancel the November meeting since it always falls on Thanksgiving, and since the December meeting would fall near Christmas, the next regular meeting of the Association will be held Thursday December 11th.

Please mark your calendar and attend the Tenth Annual Holiday Party on Saturday, December 13, 2014.

## Visitor Gate Operating Instructions



There are two ways the visitor gate can be opened:
A visitor can stop at the call box at the visitor entrance lane and using the "A" or "Z" buttons, locate the last name of the resident to be visited. When the name is selected, the visitor presses the "CALL" button. A phone call is placed to the resident, who can answer the phone. The visitor can converse with resident using the call box, and the resident can open the visitor gate by pressing 9 on his telephone key pad. If the resident does not want the visitor to enter, the resident can press the star button (\*), or hang up and the call box will be disconnected.

If residents do not have their key fob with them, residents can enter the community by using the visitor gate call box. In this instance the resident presses the pound or number key (#) on the call box followed by the last four digits of the phone number that is on record. The gate will then open. Entering pound (#) followed by 1111 will open the gate up until 8pm.



## Reaching a Milestone – 100 years strong





Dr. Stanley B. Apple, born on November 1, 1914, was one of 9 children. He lived the first 70 years of his life in Trenton & Princeton before retiring in Sarasota, FL. The last 8 years he & his wife Virginia have been residents at Enchantment.

Dr. Apple was a 4-year letterman basketball player at Trenton High School, a three-sport (basketball, football & baseball) Pennington Prep standout before taking his hard-wood floor proficiency to Wake Forest University where gained All-Conference status.

With his interscholastic & intercollegiate accolades in the books, his next chapter & first concentrated step toward becoming a doctor was enrolling in Philadelphia's highly respected Hahnemann Medical School In 1939.

After graduation he honorably served as a Navy doctor during World War II.

After the war Dr. Apple continued medical graduate work at the University of Pennsylvania, followed by his medical residency at Abington Hospital in PA.

He was a member of the American College of Surgeons and served as the Chief of surgery at Helene Fuld Hospital in Trenton for 20 years

After retirement at 70 he & Virginia moved to Sarasota, FL, where he focused this athleticism to the life time sport of golf playing until he was 90 years old age shooting his age & even a few 88s in his last year of fairway action.

Dr. Stanley Apple has 4 children, eight grandchildren and 17 great-grandchildren.


We would also like to thank Betty's granddaughter, Jacqueline, for showing us how to arm knit. It was an enjoyable evening. Thank you again, Jacqueline.
