Visitor Gate Operating Instructions

There are two ways the visitor gate can be opened:

A visitor can stop at the call box at the visitor entrance lane and using the "A" or "Z" buttons, locate the last name of the resident to be visited. When the name is selected, the visitor presses the "CALL" button. A phone call is placed to the resident, who can answer the phone. The visitor can converse with resident using the call box, and the resident can open the visitor gate by pressing 9 on his telephone key pad. If the resident does not want the visitor to enter, the resident can press the star button (*), or hang up and the call box will be disconnected.

If residents do not have their key fob with them, residents can enter the community by using the visitor gate call box. In this instance the resident presses the pound or number key (#) on the call box followed by the last four digits of the phone number that is on record. The gate will then open.

PRESIDENT -STEVE STATZ

The summer recess in business activity ended this October with a special Board meeting that approved the Finance Committee's recommended budget for next year. The new maintenance fee will be \$200 per month beginning January. The increase is due largely to the increased cost of services and an increase in the amount we are saving for our replacement reserve. We started increased contributions to this reserve last June as a result of our auditors' recommendation, following the Engineer report on the cost of replacement of our various assets.

The special meeting was followed by Candidates' Night, where the candidates for the two openings on the Board had the opportunity to present their ideas on what they would like to see if they were elected. On October 28th the community elected Allen Goldstein and Stephen Fischberg to the Board with a total of 159 of the 232 households voting.

The Robertson Douglas Group through Matt Halloran has been in contact with us to begin working on some of our transition items. It was proposed to start on some of the concrete work for sidewalk and driveway apron replacement. Concrete requires a minimum of 90 days to cure to limit salt damage. The Board has requested the concrete work be delayed until after the snow season. If our roads require salting this winter, there is insufficient cure time. Our final punch list is expected to be transmitted to the builder by the second week of November.

The gates for our community have been repaired by volunteers from our Property Committee. These repairs as well as those accomplished by the Clubhouse Committee have saved us thousands of dollars. Please consider sharing your talents and help our community by joining one of our committees. Examples of the service provided by our volunteers include the Social committee that arranges such diverse activities as dinners, dances and presentations throughout the year, and the Landscape Committee whose efforts have beautified our campus and increased the attraction of living in Enchantment. Sally Ashmen and Rosina Cifelli have been doing an outstanding job of keeping our key fobs serviced and assuring that we all have access to the clubhouse. Committee signup sheets will be available in the fall at the clubhouse. Volunteering is

a great way to meet your neighbors, keep our expenses down, and help us all to "Live the Dream".

The final testing stage for our gates will begin soon. The instructions for how to operate the visitor's gate appear elsewhere in this Chant. The final testing will begin with the visitor gate being closed and the resident gate remaining open. We request that you use the visitor gate during the testing period, so we can determine if there are any errors in the system, and to help you understand how the gate works. At the end of the test period, the resident gate will be closed from 10PM to 5AM, until the Board can address how to provide access to our community vendors, such as FedEx, post office, landscape, garbage, snow removal etc.

As we have done in the past, the November Board meeting will not be held because of Thanksgiving. The December meeting will be held in early December.

VICE PRESIDENT -TONY GAMBINO

The duties of the Vice-President shall act in the place and stead of the President in the event of the President's absence or inability or refusal to act, and shall exercise and discharge such other duties as may be required of him by the Board.

I have served just over one year as your Board Vice-President and have found it to be both rewarding and frustrating. Rewarding because so many of our residents serve on committees or volunteer their time to continue to help us "Live The Dream" here at Enchantment At Hamilton. Frustrating because of the many problems we have encountered once Robertson Douglas left. Some of our vendors do not respond in a timely manner and transition has been slow to get off the ground for various reasons. I have worked with the other Board members as we try to stay on top of all aspects that pertain to our community.

As liaison for the Clubhouse Committee I have been instrumental in obtaining written assurance from our insurance agent, that any member of our community is covered by insurance when performing duties approved by the Board. This applies to both committee members and volunteers. As a result, a sub committee for maintenance was approved as part of the Clubhouse Committee. The four men on this committee saved


us several thousand dollars by caulking patching and painting practically the entire interior of our clubhouse and performed other maintenance as needed.

I also am liaison of the Covenants Committee which worked long and hard to clarify and bring our rules and regulations up to date in order for us to live in a civilized society. These rules have been presented to the Board for their review.

As a Board member I have attended many other committee meetings.

I have worked with our Board and insurance agents to ensure that we close any gaps that we may have had in our coverage in order that we will be protected for any issues that arise in the future.

I thank you for your support. In the coming year I will continue to perform my duties to the best of my ability so that I can help us all to "Live The Dream."


like to thank Larry Guest and Tony Scalcione for their service. The time and effort that they put in to help maintain and improve our community is much appreciated by the other board members as well as the entire community.

Since Robertson Douglas left us, we are now responsible for maintaining our property. Unfortunately, this costs money and the board had to discuss and decide what should be done to keep our property the premier community in Hamilton Township. Among other things, we painted the pergolas, repaired the dormers of the clubhouse, cleaned out the retention basins, restored the power to the gates, cut down a number of large trees on our property that threatened homes, repaired the roadways, and fixed the exercise equipment.

In addition, as most homeowners know, the 2010 board inherited and had to deal with two lawsuits against the community. We incurred legal fees in order to get our current insurance carrier to provide us with a defense. We have settled one case and the other one is ongoing.

As we enter 2011 the biggest issue facing us is transition. This has been a long and frustrating process. We have our engineering report and are ready to meet with RDG. Hopefully we can get the ball rolling and start seeing some long overdue items taken care of by the developer.

Lastly, sign up sheets for 2011 committees will be set up in the clubhouse. All committees serve a vital purpose in running our community and I urge everyone to consider signing up for one or more. Some committees like the Social Committee and Hospitality help us make Enchantment more than just a place to live. Others, like Clubhouse, Property, ACC, and Landscape help maintain our community. Finance puts together a budget and helps monitor those finances. While the pay is lousy the payback can be substantial. It really does take a village. SIGN UP!

COMMITTEE REPORTS

Architectural Change Committee

Terry Bean, Chair

The ACC has been holding its regular meetings and applications have slowed down with the approach of winter. Since there was only 1 application this month it would seem that the current committee will have had it's final meeting for the year.

Clubhouse Committee

Kathy Platt, Chair

The clubhouse committee was very busy this quarter with a few projects. At the suggestion of one of our



members we requested Wentworth to contact PSE&G and set up a service contract on the heaters and air conditioning units for the clubhouse. This

was done a few months ago and has already been used. There was a problem with a unit that controls the heat and air conditioning in the card rooms. PSE&G repaired the problem under the maintenance contract. During the time the maintenance agreement was being set up we contracted with a HVAC company to balance the systems. They found the problem with the unit for the card room. We then requested Wentworth to request the repairs to be done by PSE&G. This should cure some of the air flow problems that we have been experiencing in the building.

We have been discussing the possibility of putting blinds on the windows in card rooms. We are currently getting prices before any decision can be made. Members of the Enchantment community have been requesting something be done with the windows since they are the only ones in the building that do not have some form of sun shield. It would also be nice to have privacy for the card players in the evenings.

Our cleaning contractor is doing a great job cleaning clubhouse.

At the last clubhouse meeting it was decided by all

members that were present to merge the clubhouse maintenance committee with the properties committee. The clubhouse maintenance committee did a fabulous job with many projects that they completed in the building, such as caulking, painting, and repairing items in need. This was a great cost saving to our community.

Covenants Committee

Ted Furman, Chair

In August, the Covenants Committee submitted an updated set of rules to the Board for their review. Our objective has been to update the rules to more accurately reflect changes which have taken place since the current Rules were published in August 2007. It has not been our intention to completely rewrite the rules. That said, much of what was originally in our rules was drafted in the early days before we had a history with using our facilities and before we had experience governing ourselves as a community. Indeed, the first rules were drafted before our Clubhouse even opened so that some framework would be in place when people started using our facilities. Revisions fall into four (4) basic categories:

- Rule changes approved by the Board since August 2007;
- 2) Rule amendments suggested during this committee's 2010 discussions with other relevant committees (Social, Clubhouse, Pool, Judiciary, and other Committees took the time to provide us with their own updates);
- 3) Rule clarification where the original language was unclear, or where the rule is no longer relevant;
- 4) Additions regarding items like key fobs, snow removal procedure, and the like, which have arisen over the past couple of years.

In addition to a revised set of rules we also provided some suggestions on archiving rule changes which are approved at Board Meetings and General Meetings so as to facilitate future updates to the rules document. We have also made suggestions regarding consistent use of our vendor policy. Finally, we are putting the finishing touches on a 'best practices' pamphlet designed to capture best practices and missions of committees to serve as a set of guidelines for new committees and new committee members each January.

I would like to thank all of the members of the Covenants Committee for their hard work and lively discussions this year. I would also like to thank our Board Liaison, Tony Gambino. And a special thanks to co-chair, Renee Guest, who worked tirelessly on capturing all of our thoughts and ideas through numerous iterations into the revised rules document we finally submitted to the Board. The review of the revised rules is ongoing by the Board



Enchantment Phantom Investment Club ("EPIC")

Allen Goldstein, Chair

What are alternative energy sources and would they be a good investment opportunity for you? What are master limited partnerships ("MLPs") and exchange

traded funds ("ETFs") and what advantages do they offer to you as investors? These questions were addressed at EPIC's August and September 2010 meetings.

At the August meeting, our community resident scholars on alternative energy sources, Sandie Simpson and Steve Statz lead us in a discussion of both the positives and negatives of various alternative energy sources and their likelihood of generating attractive investment returns should they be added to the EPIC "play money" investment portfolio. At the September meeting, John Bartolino introduced us to MLPs and we discussed why these securities offered both attractive distribution rates and price appreciation opportunities. We also discussed how an ETF would enable us to invest outside the United States.

Our October meeting was deferred as a number of members were not available during the first week of October and more importantly, we are investing aggressively and needed to defer investing for one month to get back on schedule with our plan to invest "play money" of about \$10,000 per month. At October 31, 2010, the EPIC investment portfolio includes a Chinese company, Brazilian companies through an index ETF and US companies that provide domestic and global products and services such as consumer products, energy transmission services, financial services, health care technology, industrial products, pharmaceuticals, public utility services, and telecommunication services. Many of these companies provide attractive dividend yields as well as price appreciation opportunities. Since we started investing at the beginning of June through October 31, our total return is 8%. Our 2 buys at the beginning of September and the entire portfolio performed well during September and October. We likely benefited from the best October stock market in four years. At the beginning of September the portfolio

had a small loss from June when we began and we recognize that prices go up and down so we have a lot to think about in order to sustain the portfolio's growth and income in the future.

Should you be interested in learning about EPIC and its mission to learn about investing, please attend a meeting. We normally meet the first Tuesday of the month in the clubhouse at 7pm. Alternatively, you can speak with any of the core members of our club; (there are about 20 members who are on our distribution list); the core members have attended many of our meetings. They are John Bartolino, Roseann Carbonara, Dominick Chianese, Ellie Friedberg, Allen Goldstein, Stuart Goss, Gary Johnson, Dan Nitka, Chris Pontani, Sandie Simpson and Jill Weinberg.

At future meetings, there are plans to discuss commodity, currency, derivatives and real estate investing as well as comparing long-term investing to trading for short term profits. AN IMPORTANT MESSAGE FROM YOUR WEBMASTER MARK MALESON

The easiest way to communicate community related things is through the enchantmentathamilton.org web site. The site provides several ways to email ALL, email SELECTED, email members of committees and email the board (which includes the management company).

Of the 232 houses in our community there are 27 that have not provided an email address. There are 18 houses that have provided neither a telephone number nor an email address.

Currently 62 of our registered email addresses use an AOL email address. Many times these 62 email users do not get the intended information. The message that is consistently returned to me indicates that the AOL mail service is not available. This doesn't happen all of the time to you AOL users, but practically NEVER happens to any other email address.

My suggestion to the AOL users would be to establish a second email address through Cablevision/Verizon or another web based email provider. We currently have 80 registered OPTONLINE email addresses and 15 VERIZON email addresses. There are 31 YAHOO email addresses, 8 MSN, 8 GMAIL 10 HOTMAIL and a few that are probably work or business related. The point here is that there are many free email providers that would give you the opportunity of being in contact with others in our community more of the time.

If your e-mail address changes, for example, due to switching from CABLEVISION to Verizon, please email me at mmaleson@optoline.net so that I can update our homeowners list. Also email our management company so that they can change their records.

I do understand that for those of you that have been using AOL for a long time that you might not want to switch, so my suggestion is to keep your AOL email address and open a second email account with another provider. Tell us what your new email address is to change our Enchantment database and then check your new email account periodically to see if there is any enchantment news.


